

TWO FIFTEENTH-CENTURY LETTERS TO THE GENERAL CHAPTER  
Staatsarchiv Wertheim F 73a/68

Among the Carthusian remains shown to the participants in the Tückelhausen congress on Carthusian History and Spirituality was an exhibition in the Staatsarchiv Wertheim of documents from the former Charterhouse of Grünau. This collection of forty-three items included official letters and bulls concerning the foundation of the house, services and devotions which took place there, correspondence concerning members of the Charterhouse, documents concerning its library and some of the books which had belonged there. All of the documents in this exhibition were described in a handbook catalogue compiled by the archivist, Dr. Hermann Ehmer, to whom we owe a debt of thanks for drawing our attention to a pair of letters from two of the monks of Grünau to the General Chapter, and thus peripherally concerning the edition of the records --the *Cartae*-- of the Chapters.

The fifteenth-century legislation concerning private correspondence with the General Chapter or the Reverend Father of the Order sets out a series of interesting conditions: an ordination of 1437 states that: "persons writing to the Carthusian Reverend Father or the General Chapter should not begin their letters with prohems or harangues, but immediately after an honest and brief recommendation should enter with due speed into the subject of their petitions; which they should separate into articles such that responses may conveniently be given to them. Otherwise, no response shall be made." Another ordination, of 1429, decrees that any Prior, Visitor or other person opening or reading a sealed letter, or impeding its effect, cannot be absolved of this presumption without special licence; on the other hand, monks writing such letters should take care not to write falsehood, if they wish to escape the punishment decreed by Statute. An ordination of 1460 states that because of the growth in number of the houses of the Order, and of their business, it is no longer possible for the Reverend Father to deal separately with all questions; henceforward, all correspondence is to be addressed jointly to the Reverend Father and the Diffinitors of the General Chapter, or it will not be answered. The confirmation of the following year specifically excepts secret matters which are not to be publicized: these may be communicated to the Reverend Father privately.

It is clear that the two letters from Grünau surviving in the Staatsarchiv Wertheim, each containing a series of separate questions with space for responses, addressed simply to the Reverend Father, Prior of the Grande Chartreuse, and other Diffinitors of the General Chapter, and folded so that only the return address was visible from the outside, were written in conformity with these

regulations. The first letter transcribed below is written simply on both sides of a single sheet of paper, which was then folded twice breadthwise, to approximately one-fourth its original length, then once across, and then into thirds, so that only a small square, bearing the name of "Waltherus, professus in Grünau," its addressee, was visible. This letter was addressed to a "Domino Francisco, Priori Maioris Carthusie" -- thus, since it is written in a mid-fifteenth century secretary hand, it was probably written during the priorate of François Maresme, 1437-1463. The questions in this letter concern the minutiae of the office (whether the first syllable of the word "felix" in the last line of the first verse of the hymn "Ave, maris stella" -- and thus all words in this position in their respective verses -- should be sung with two notes or three, etc.) and the correction of some readings in the Statutes, as well as some questions of more obvious importance. The Reverend Father is asked to specify the four causes reserved to the Apostolic See which Priors may absolve by special commission, for there is a case in the house in which there is some doubt as to the authority of absolution; more specifically, he is asked if it is possible to absolve a willful homicide within the Order from his sins and excommunication, but not from his irregularity. This query might be the result of the letter of indulgence granted by Pope Pius II and published in the Carta of the General Chapter of 1461, which granted to every member of the Order a plenary indulgence, with dispensation from irregularity -- one practical result of which would be the freeing of a willful homicide from his sentence of imprisonment.

The questions of the second letter transcribed below, addressed to "Domino Johanni, Priori Maioris Carthusie" -- John of Roesendael, 1463-1472 -- are of neither as low nor as high an order as the others, and concern themselves with the resolution of various occasionally conflicting offices and responsibilities in the Order and the house at Grünau. The format of this letter requires comment, however. As Dr. Ehmer, who was kind enough to compare the transcript below with the original documents, pointed out, this letter has been folded into octavo format, and written out on the four "pages" thus created. The inside address and the signature of "Syfridus in Grünawe" occur at top and bottom of the first page; the return address occurs at the bottom of the fourth page; and the whole set of four pages was folded twice breadthwise and once across -- again, so that only the return address is visible from outside. The transcript given below is altered, however, to reflect a textual anomaly: the only question in the letter to begin with the word "Quero" is that at the top of the fourth page -- the upper left corner of the sheet when re-opened. All other questions begin with the repetitive "Item" -- including that at the top of the first page. Thus, while the format of the letter would indicate one order for its contents, the logic of its expression would indicate another. The choice has been made -- one hopes not

arbitrarily -- to represent the latter here. To reconstitute the former, the reader needs only begin with the first page (page b of the recto of the second letter, or 2rb, in the transcript) and continue to the end, adding there the questions, but not the inside address, of the fourth page (2r) in the transcript.

The rules of transcription used here are those of the edition of the *Chartae*:<sup>1</sup> all suspensions are expanded silently, with the exception of the ampersand, which is reproduced; capitalization and punctuation are modernized, but generally following indications in the original; and the spellings "ihs", "xpc" and their declined forms are represented by their modern spellings "Jesus", "Christus", in order to avoid the false form "Jhesus", unless specifically spelled out that way by the scribe. The two sides of the first letter are designated "1r" and "1v" in the left margin; the pages of the second letter are designated "2r", "2rb", "2v" and "2vb". All responses are interlineated in the transcript, but only the lines of the original questions are counted in line-numbering.





